10 PLEASE TAKE NOTICE that this Court has entered an Order fixing July 30, 2002 as the
11 deadline for all persons and entities to file requests for allowance of administrative claims
12 pursuant to 11 USC § 503 and 11 U.S.C. §§ 101, *et seq.* ("Administrative Claim") which arose
13 during the period from August 24, 2001 through June 15, 2002, inclusive, against the
14 above-captioned debtors, except for the Administrative Claims described in paragraph 2 below.

14 1. **FILING OF A REQUEST FOR ALLOWANCE OF ADMINISTRATIVE CLAIM.**

16 All persons and entities, including, without limitation, individuals, partnerships
17 corporations, estates, trusts and governmental units seeking to have an allowed Administrative
18 Claim against the Debtors pursuant to 11 USC § 503 which arose during the period from
19 August 24, 2001 through June 15, 2002, inclusive, must file an Administrative Claim.

19 2. **WHO IS NOT REQUIRED TO FILE A REQUEST FOR ALLOWANCE OF ADMINISTRATIVE CLAIM, BUT MAY DO SO.**

21 You are not required to file a request for allowance of Administrative Claim for the types
22 of claims set forth below, but may do so:

- 23 a. Administrative Claims of professionals retained by Court order in this case
24 for fees and expenses subject to approval pursuant to 11 USC §§ 330(a) and
25 503(b);
26 b. U.S. Trustee's claims under 28 U.S.C. § 1930(a)(6);

- 1 c. Any Administrative Claim as to which an order of the Court has been
2 entered setting a later bar date for filing such Administrative Claim against
3 the debtors;
4 d. Any Administrative Claim as to which an order of the Court has been
5 entered allowing such Administrative Claim; and
6 e. Administrative Claims arising after June 15, 2002.
